CENTSAI TERMS OF USE AGREEMENT

Welcome to CentSai, operated by CentSai Inc. ("CentSai," "CentSai", "we," or "our"). By using the websites located at centsai.com and/or centsaiadulting.com., (the "Websites" or the "Sites") you agree to be bound by these Terms of Use (this "Agreement"), whether or not you register as a member of CentSai ("Member"). If you wish to become a Member and/or make use of the CentSai service (the "Service"), please read this Agreement. If you object to anything in this Agreement or the CentSai Privacy Policy, do not use the Websites or the Service. This Agreement is subject to change by CentSai at any time, effective upon posting on the Websites. Your continued use of the Websites and the Service following CentSai's posting of revised terms of any section of the Agreement will constitute your express and binding acceptance of and consent to the revised Agreement.
